OFFICE ORDER

SUB:- AMENDED ORDER UNDER RULE -10 FOR SOCIAL DISTANCING

WHEREAS, the Government of Maharashtra, in exercise of the power conferred under section 2, 3 and 4 of the Epidemic disease act, 1897 has framed Regulations for prevention and containment of COVID - 19 under no. 2020/CR/58/ Aarogya-5 dated 13th march 2020.

AND WHEREAS under rule 10 of the said regulation the Municipal commissioner is authorized to take any measures for containment of COVID- 19

I Annasaheb Misal, Municipal Commissioner of Navi Mumbai Municipal Corporation, in exercise of said powers conferred upon me hereby direct under rule 10 of the said regulation to implement the following containment measure in the jurisdiction of Navi Mumbai Municipal Corporation.

1. Restricting the vehicular movement in the area of Isolation Centre, Quarantine Centre declared by Navi Mumbai Municipal Corporation like General Municipal hospital Vashi, Quarantine Centre Sec. 14 Vashi Navi Mumbai.
- 2) Closure of Day Care Centre, Play School, Schools, Colleges, Cinema halls, Malls, SGNP swimming pools, Saloons, Beauty Parlors, Spa, Massage centers, Gym Clubs, Pubs, Dance Bars, Amusement parks, Gardens etc. Banning mass congregations, functions in the NMMC Jurisdiction and Hawkers selling Food/juice on road/footpath till further orders.
- 3) All Shops, Commercial activities Private/ Corporate Establishments/ offices, Production and Manufacturing units to be completely shut down till further orders.


However following establishments providing essential services shall be excluded :-

- a) Drinking water supply services
- b) Sewerage and sanitation services
- c) Banking services and their Back Offices (Only essential Staff).
- d) Insurance Companies and their Back Office support (Only essential Staff).
- e) Telephone and Internet Services and their Back Office support (Only essential Staff).
- f) Food, Groceries, Milk, Bread, Fruit, vegetable and their transportation related activity and their godowns. Including on line home delivery services like Swiggy / Zomato etc..

- g) Hospitals, Medical/Chemist stores and their godowns, Medical Equipment Industry, Pharmaceuticals and their Formulations companies and their transportation related activities.
- h) Electricity, Petrol pumps, Oil Agency, their godowns and their transportation related activities.
- l) Medical and Nursing Colleges.
- J) Data Centers, IT services related to the above essential services (Only up to 10% of their total staff strength)
- k) Media
- L) Production/ Manufacturing units which require continuous process may continue to function up to 25% of their total Staff strength.
- 4) Asst. Municipal Commissioners and Police Officers to issue advisory to people not to gather in masses at Mini Sea Shore, Sagar Vihar, Jogging tracks etc..
- 5) Spitting on any public place, premises, road will attract a fine of Rs 250/- Sanitary staff of the ward and Police are hereby directed to enforce this punishment strictly.
- 6) If there is any discrepancy about as to whether a service or establishment is essential or not, the Municipal Commissioner shall give the final decision.

Asst. Commissioner of the wards and Zonal Dy. Municipal Commissioner of NMMC and the Sr. Police Inspectors, ACP (Vashi / Turbhe) and DCP Zone 1 are hereby authorized to take all necessary actions for implementation of the aforesaid measures.

Any person found violating the containment measures shall have been deemed to have committed an offence punishable under section 188 of Indian Penal Code (45 of 1860).
