OFFICE ORDER

SUB:- Guidelines for Cooperative Housing Society/ Industries/Builders for doing pre monsoon repair work for prevention and Containment Measures of COVID-19 in the jurisdiction of Navi Mumbai Municipal Corporation.

WHEREAS, the Government of Maharashtra, in exercise of the powers conferred under section 2, 3 and 4 of the Epidemic disease act, 1897 has framed Regulations for prevention and containment of COVID - 19 under no. 2020/CR/58/ Aarogya-5 dated 13th march 2020.

AND WHEREAS under rule 10 of the said regulation the Municipal Commissioner is authorized to take any measures for containment of COVID- 19.

AND WHEREAS as per the protocol given by Ministry of Health & Family welfare Directorate General of Health Services EMR Division an appropriate Management of Suspect/confirmed cases of COVID-19 in the jurisdiction of Navi Mumbai Municipal Corporation.

I Annasaheb Misal, Municipal Commissioner of Navi Mumbai Municipal Corporation, in exercise of said powers conferred upon me hereby under rule 10 of the said regulations gives guidelines to Cooperative Housing Society/ Industries/Builders for doing pre monsoon repair work for prevention and Containment Measures of COVID-19 in the jurisdiction of Navi Mumbai Municipal Corporation.

- 1) The Society/ Builder/ Industrial Establishment shall start the repair work only after it is inspected by the AMC wards and the Deputy Eng Civil. The AMC Wards shall give the approval to start the incomplete repair monsoon work.
- 2) The Society/ Builder/ Industrial Establishment should make the staying facility arrangement of the pre monsoon repair work labor in their premises. Once the laborer joins the work he shall not be allowed to go home.
- 3) It will be the responsibility of the Society/ Builder/ Industrial Establishment that every person who will be engaged in the repair works should be screened by the In charge Medical Officers of UPHC before they start the work.
- 4) It will be the responsibility of the Society/ Builder/ Industrial Establishment shall wear three ply mask and hand gloves.
- 5) The Society/ Builder/ Industrial Establishment shall keep hand sanitizers or soap and wash basin at the work place.
- 6) The Material required for the entire repair work should be stored once only in the Society/ Builder/ Industrial Establishment premises.
- 7) The material delivery vehicle should not be allowed to enter the Society/ Builder/ Industrial Establishment premises beyond the restricted area.

- 8) The Society/ Builder/ Industrial Establishment should provide food for the laborers which should be prepared in house.
- 9) Any staff engaged in the repair work develops symptoms of fever, cold, Sore thorat and breathlessness should be immediately referred to the nearest UPHC.
- 10) The Society/ Builder/ Industrial Establishment who have started their work before the lock down and couldn't complete the repair work shall complete the repair work by implementing the aforesaid containment measures. However the Society/ Builder/ Industrial Establishment who have not started their repair works preferably should postpone for the next year.

AMC Wards, Sr. Police Inspector of the local police station is hereby authorized to take all necessary actions for implementation of the aforesaid measures.

Any person found violating the containment measures shall have been deemed to have committed an offence punishable under section 188 of Indian Penal Code (45 of 1860).
